On 30 October 2014, the Purchaser (a wholly-owned subsidiary of the Company) and the Vendor entered into the Acquisition Agreement in relation to the acquisition of the Sale Share at an aggregate consideration of HK\$900 million, which shall be satisfied (i) as to HK\$120 million by cash and (ii) as to HK\$780 million by the issuance of Convertible Note by the Company on Completion. In respect of (i) above, the Company will raise funds of HK\$120 Million through the placing of 111,111,111 new shares to not less than six places at a placing price to be determined. In respect of (ii) above, the Company will issue Convertible Note in the aggregate principal amount of HK\$780,000,000, which entitles the Noteholder(s) to convert into a total of 722,222,222 new Shares of the Company at the Conversion Price of HK\$1.08 per Conversion Share (subject to adjustments).
